OFFICE-ORDER


Kendriya Vidyalaya Sangathan vide office-order of even number dated 08.03.2019, conveyed the approval of Government of India, for establishing 50 new Kendriya Vidyalayas under Civil Sector with the stipulation that the sponsoring authority concerned is required to transfer the identified and demarcated land and also to give possession of the same to KVS prior to opening of the new Kendriya Vidyalaya. **Kendriya Vidyalaya N.F. Railway Rangapara, Distt. Sonitpur (Assam)** is one of the 50 new Kendriya Vidyalayas sanctioned.

Since the land in the matter of this Kendriya Vidyalaya has been transferred by the Sponsoring Authority in favour of Kendriya Vidyalaya concerned, sanction of the Commissioner, KVS is hereby conveyed to start a new Kendriya Vidyalaya under Civil Sector with immediate effect, at the following location:-

Office-Order

The Ministry of HRD vide email dated 08th March, 2019 has forwarded the D.O. No. CCEA/07/2019(x) dated 07.03.2019 conveying the approval of Government of India for setting up of 50 new Kendriya Vidyalayas under MHA/Railways/Civil Sector all over the country whereby the sponsoring authorities have scored maximum weightage points under the "Challenge method".

2. Further, pursuant to clause-I (ii) of Annexure-I of the norms prescribed for opening of new Kendriya Vidyalayas under Civil Sector, the sponsoring authority is required to transfer the identified and demarcated land to Kendriya Vidyalaya Sangathan on lease or permanent transfer basis prior to opening of the new Kendriya Vidyalayas. Besides, the temporary building where the sanctioned KV will run initially (till the permanent building of KV is constructed) also needs to be handed over to the Kendriya Vidyalaya authority.

3. Necessary administrative sanction orders for the opening of the new Kendriya Vidyalaya will be issued immediately after transfer of the land & temporary building in favour of Kendriya Vidyalaya and after their possession is given to Kendriya Vidyalaya Sangathan. Therefore, all sponsoring authorities are required to transfer the requisite extent of land in favour of KV and also fulfil the requirement of transfer of temporary building to Kendriya Vidyalaya authorities for running of Kendriya Vidyalaya besides completing other requirements.
